2. I possess and agree to use all of the necessary equipment required to participate in the training and all of said equipment is in proper working order.
3. I agree to abide by all rules and instructions as set forth by the training instructors, supervisors and employees.
4. I agree to hold harmless and waive all claims arising from my participation, observation or attendance of said training for damages to myself, my property or property of others under my control and supervision arising out of action or inaction, through any negligence or otherwise other than deliberate and intentional tortuous action by the Champion Rescue Tools, its agents and employees in both their official and personal capacities.
5. Further, the protection of the Waiver of Liability and agreement to hold harmless extends to all claims that might devolve to the benefit of my heirs, assignees, administrators or executors, including but not limited to, all claims arising from my wrongful death or injury.

Further, the protection of the Waiver of Liability and agreement to hold harmless extends to all cooperating organizations, corporations and individuals, their agents and employees, in both official and personal capacities, who are assisting Five Star Training Academy in the presentation and conduct of this training.
